  - a. Ex: http://www.ebrokerhouse.com/property\_search.php?id=505
  - b. Also notice that there may be a Required Lender for this property. If this is the case, this information will appear directly below the property information.
  - c. You also have the ability to see how many offers have currently been submitted on this particular property if the listing agent chooses to allow this information to be displayed.


